Hospital Rooms promotes the improved health and wellbeing of mental health service users by enhancing environments in mental health hospitals through the provision of high-quality and compliant design, art and creative activity.

Nick Knight OBE, who is among the world's most influential and visionary photographers, selected *Pale Rose* to be installed in the Communal Lounge at the Phoenix Unit. The composition was created by printing a still life image of roses onto acetate and then causing the ink to drip by exposing it to heat and water before it dried.
